 This tournament is open to all Twin CitiesUSBC Members. Non USBC members may purchase a USBC Associate Membership for \$24.00. Non TwinCities Members may purchase a Twin Cities Membership for \$8.00 (plus \$3 State fees if applicable). Junior Bowlers will be allowed to bowl in this event with all monies going into the USBC Smart Account in their name if they qualify for the prize fund. If they win, then the first Adult Winner will receive Paid Entry into the USBC Masters.

- 2) Entry Fee = \$90.00. All prize fees are returned 100%.
- 3) Entries will close after the first 96 paid entries are received.
- 4) A paid entry becomes the property of the Twin Cities USBC (no refund of entry fees.)

#### 5) PRACTICE WILL START AT 8:45 AM

Check-in begins at 7:30AM Squad time is 9:00 AM

6) 8 game Qualifying begins at 9:00 AM.

Top 8 will bowl match play base on 35 or fewer entries, 36 - 47 entries top 12, 48 - 71 entries top 16 72 - 95 entries top 24, 96 entries and above, top 32.

A 1 game roll off will determine the winner of any ties for last place for match play. A 9th and 10th frame will be bowled if a tie still exists.

The Match Play finals are a <u>1 game double elimination</u> format with the winners decided by a one game total pinfall. A 9th and 10th frame roll off will determine the winner of any ties.

7) The USBC rule prohibiting use of any abrasive on the surface of the bowling ball during competition WILL BE ENFORCED with immediate disqualification and forfeiture of entry fee. Abrasives may be used after re-oil and prior to match play. Dry towels only are allowed during competition.

#### 8) NO ENTRIES ARE RESERVED WITHOUT ENTRY FEES.

- 9) There will be \$5 brackets conducted during all qualifying competition. 2 flights: Games 2-4, and 5-7.
- 10) Winner will have 60 days to inform the BowIng Office as to his or her intentions of going to the National Masters Tournament, if the Champion is not able to go, the 2<sup>nd</sup> place bowler will be asked to go. After that prize money will be added into next years prize fund.
